This matter is before the Court on Defendant Archatas, Inc.’s (“Archatas”) Motion for Summary Judgment pursuant to Civ. R. 56. The Court finds said Motion well taken pursuant to the authorities and arguments contained therein and hereby finds in favor of Defendant Archatas, Inc. as to Plaintiffs State Farm & Fire Casualty Company, Mount Air Condominium Association, Amica Mutual Insurance Company, Joshua Dressler, Dorothy Dressler, and Intervening Plaintiff State Farm Fire & Casualty Company a/s/o Terry Scherer’s (collectively “Plaintiffs”) claims.

The Court further finds that Defendant Archatas as the moving party has satisfied its Civ. R. 56 burden and Plaintiffs have failed to set forth specific facts showing that there is a genuine issue for trial. Moreover, Plaintiffs have failed to make a showing of evidence as to the existence of expert testimony that Archatas failed to meet the applicable standard of care. Accordingly, Defendant Archatas is entitled to judgment as a matter of law.
